ADDENDUM

Publicity. Each party shall obtain the prior written consent of the other party concerning the content and plan of distribution of any public announcement, press release or advertisement concerning this Agreement. However, consent may be withheld by ABC Charities in its absolute discretion. This Agreement will immediately terminate if ABC Charities' name is used or otherwise disclosed without ABC's consent.

Confidentiality. Both Parties acknowledge that during the term of this Agreement, either Party may gain access to Confidential Information of the other Party, including donor information and patient information. Each Party shall protect the other Party's Confidential Information from unauthorized dissemination and use the same degree of care that such Party uses to protect its own like information, but in no event less than reasonable care. Neither Party shall use the other Party's Confidential Information for purposes other than necessary to directly further the purposes of this Agreement. Such purposes may include, but are not limited to, disclosures of Confidential Information in connection with the services provided by XYZ Catering Company. Both parties acknowledge that the restrictions relating to Confidential Information contained in this Agreement are reasonable and necessary to protect their legitimate interests, that violation of these restrictions could cause damage to the other Party, and that the other Party will be entitled to injunctive relief against each violation.

Standard of Care. It is agreed that the standard of care imposed upon XYZ Catering Company. by this Agreement is to act with the care, skill prudence, and diligence under the circumstances then prevailing that a prudent person acting in a like capacity and familiar with such matters would use in the conduct of an enterprise of a like character and with like aims.

Control of Work. XYZ Catering Company. shall be solely responsible for the conduct and control of the work to be performed under this Agreement by XYZ Catering Company. and its agents or employees.

No Agency. XYZ Catering Company. shall perform the services hereunder as an independent contractor and nothing contained herein shall be deemed to create any association, partnership, joint venture, or relationship of principal and agent or master and servant between the parties hereto or any affiliates or subsidiaries thereof, or to provide either party with the right, power or authority, whether express or implied, to create any such duty or obligation on behalf of the other party.

Modification. No modification, waiver or amendment of any term or condition of this Agreement shall be effective unless and until it shall be reduced to writing and signed on behalf of XYZ Catering Company. and (venue name) and ABC Charity.

Severability. If any term or provision of this Agreement should be declared invalid by a court of competent jurisdiction, the remaining terms and conditions of this Agreement shall be unimpaired.

Assignment. XYZ Catering Company. may not assign this Agreement without the prior written consent of ABC Charity

Paragraph Headings. Section headings are for convenience only and shall not be considered part of the terms and conditions of this Agreement.

Indemnification. Each party agrees to defend, indemnify, and hold harmless the other party, its parent(s), subsidiary(ies), affiliated and related companies, and their respective directors, officers, employees, and agents from any and all claims, demands, liabilities, lawsuits, settlements, actions, damages and expenses whether or not litigation is commenced (including without limitation, reasonable attorneys' fees) arising from or related to any gross negligence or acts of willful misconduct by that party, its employees, agents officers or directors, exclusive of any liability resulting from the negligence of the other party, its agents or employees.

ABC Charity agrees to defend, indemnify and hold harmless both XYZ Catering Company. and (venue name) . and their parent(s), subsidiary(ies), affiliated and related companies, and their respective directors, officers, employees, and agents from any and all claims, demands, liabilities, lawsuits, settlements, actions, damages and expenses whether or not litigation is commenced (including without limitation, reasonable attorneys' fees) arising from or related to use of food products donated to ABC Charity for the event.
